## ORDINANCE 2007 - J

## A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PLUMAS EUREKA COMMUNITY SERVICES DISTRICT TO ESTABLISH A FEE SCHEDULE FOR OUT OF DISTRICT FIRE AND EMERGENCY RESPONSES.

WHEREAS, the Plumas Eureka Community Services District (hereinafter the "District") is a municipal corporation established and operating under the provisions of the Community Services District Law, Section 61000 et seq of the California Government Code (hereinafter the "Act"; and

WHEREAS, the District is managed and controlled by a Board of Directors (hereinafter the "Board"); and

WHEREAS, the District's Fire Department Division acting under the name of Plumas Eureka Fire and Rescue (hereinafter the "Department") has provided fire and emergency services to areas outside of the District that are not covered by other Fire Districts; and

WHEREAS, the Board is concerned about the related costs to the District for fire equipment and personnel to respond to areas outside of the District; and

WHEREAS, the Board is in agreement that when the Department responds to areas not covered by a Fire District, that the individual(s) they respond to will be charged for services rendered

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE BOARD OF DIRECTORS OF THE PLUMAS EUREKA COMMUNITY SERVICES DISTRICT AS FOLLOWS:

1. CHARGES: Commencing at the time of Dispatch, the following charges will apply for the various types of equipment and personnel on a per hour basis with a minimum one hour charge;
