

## RESOLUTION NO. 2014 - 93

### A RESOLUTION OF THE BOARD OF DIRECTORS OF THE PLUMAS-EUREKA COMMUNITY SERVICES DISTRICT ELECTING TO PLACE DELINQUENT CHARGES AND PENALTIES ON THE TAX ROLL

WHEREAS, the Board of Directors of the Plumas-Eureka Community Services District ("District") is authorized by Government Code section 61115(a) to provide, by resolution or ordinance, for the collection and enforcement of rates and other charges for services and facilities the District provides; and

WHEREAS, the Board of Directors is authorized by Government Code section 61115(b) to provide that "any charges and penalties may be collected on the tax roll in the same manner as property taxes"; and

WHEREAS, the Board finds and determines that it would be to the District's benefit to collect delinquent charges and penalties on the tax roll following the procedures set forth in Government Code section 61115(b);

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE PLUMAS-EUREKA COMMUNITY SERVICE DISTRICT, as follows:

Section 1. The Recitals are true and correct and are incorporated herein.

Section 2. The District elects to include the amount of delinquent charges and penalties on the tax bills for each affected parcel of real property and collect the charges and penalties in the same manner as property taxes pursuant to the procedures set forth in Government Code section 61115(b).

Section 3. The General Manager provided notice of the District's election in Section 2 to the affected property owners and other interested parties as required by Government Code section 61115(b). The Board of Directors conducted a public hearing on July 9, 2014 regarding the delinquent charges identified in Section 4. All procedural requirements for placing the delinquent charges on the tax rolls have been followed.

Section 4. The Board of Directors hereby receives and approves the report set forth in Exhibit A, incorporated by this reference. The General Manager shall forward the report and this Resolution to the County Auditor and
