RESOLUTION 96-15

WHEREAS, the Plumas Eureka Community Services District (the "District") is a municipal corporation established and operating under the provisions of the Community Services District Law, Section 61000 of seq of the California Government Code (the "Act"); and

WHEREAS, the District is managed and controlled by a Board of Directors (the "Board") and has control of its own revenues and funds; and

WHEREAS, Plumas County (the "County") does not snow plow or maintain the roads named Pine Cone Court, Meadow Lane, West Pinion Pine Circle, East Pinion Pine Circle, and Ponderosa Drive; and

WHEREAS, Section 61600 (j) of the California Government Code states "The opening, widening, extending, straightening, surfacing, and maintaining, in whole or part of any street in such District, subject to the consent of the governing body of the county or city in which said improvement is to be made." Which the District interprets to mean snow removal and eventually road maintenance; and

WHEREAS, the Board has determined that a percentage of property tax monies should be set aside for the snow plowing and eventual maintenance of the aforementioned roads. And that a record of all expenses and labor time will be tracked. And when to plow the snow will be at the discretion of the plow operator: and

NOW, THEREFORE, IT IS HEREBY RESOLVED, DETERMINED AND ORDERED BY THE BOARD OF DIRECTORS OF THE PLUMAS EUREKA COMMUNITY SERVICES DISTRICT AS FOLLOWS:

1. Declaration of Intent. The Board does hereby declare its intention to create a budget category to be known as Roads and authorize the withholding of 3.625% of property tax monies received from the County for the funding of said budget category.

- 2. Said funds will be used to offset costs of snow plowing and eventual maintenance of the aforementioned roads. A record will be kept of all expenses, and an internal rate of \$40.00 per hour for services will be charged against the snow plowing and eventual maintenance category.
- 3. Effective Date of Resolution. This Resolution shall take effect from and after its passage and approval.
