

RESOLUTION 95-1

RESOLUTION OF THE PLUMAS EUREKA COMMUNITY SERVICES DISTRICT TO ESTABLISH WATER RATES, AS ADOPTED FEBRUARY 2, 1994.

The Plumas Eureka Community Services District shall be divided into two (2) Service Zones for the purpose of setting rates for the delivery of domestic water to its customers. Rates for domestic water service for each parcel served shall consist of two (2) components, namely a service charge component and a commodity charge component. These rates are effective January 1, 1994 and shall remain in effect until modified by the District.

Service Zone 1 shall be that physical area of the District such as existed on December 31, 1993. The total charges for domestic water service for each parcel in this Service Zone 1 shall be:

Service Charge	\$180.00 per year
Commodity Charge	\$ 0.00 per year
Total Charge	\$180.00 per year

Service Zone 2 shall consist of all those future areas that may be annexed to the District. The total charges for domestic water service for each parcel in this Service Zone 2 shall be:

Service Charge	\$180.00 per year
Commodity Charge	\$150.00 per year
Total Charge	\$330.00 per year
